AZTOOLKIT HIGHLIGHTS



AZToolkit helps early learning providers meet the daily demands of the business administration side of their work by providing the resources needed to manage their programs more efficiently and effectively. With more than 1,800 tools and resources currently available on AZToolkit, professionals are given the much needed bandwidth to spend fewer resources on administrative tasks — and more time focusing on improving quality for children and families.

How We Built AZToolkit

AzAEYC built AZToolkit through an extensive process over a nine month period in 2017 in collaboration with CCA for Social Good. AZToolkit is powered by CCA Global. The platform is generously supported in Arizona by a three-year grant from the Virginia G. Piper Charitable Trust. AzAEYC joins organizations in over 30 states that have adopted and customized their own ECE Shared Resources platform by working with CCA Global. The result is a comprehensive shared services system for early education professionals across the country.

|  3 | Maximize Parent Choice & Family Engagement | AZToolkit offers ECE programs specific family engagement resources and activities to support active engagement of families in the healthy development of their children (inside and outside early learning settings). |

|  5 | Develop & Implement Strategies to Strengthen Business Administration Practices and Improve Overall Quality | AZToolkit is the first tier of a statewide shared services construct, which will also include deeper shared services offered within communities based on practices in AZ and other states (and communities).
